Such capital reserve fund shall be for a probable term of twelve (12) years and will commence on June 30, 2020 and expire on June 30, 2032. The capital reserve fund will be capitalized in a total amount not to exceed Ten Million Dollars (\$10,000,000), plus interest, during the term of the fund. The source of the funding of the capital reserve fund shall include an annual transfer of surplus money, if any, from the District's General Fund's unassigned fund balance, as may be available as of the end of each fiscal year from June 30, 2020 through and including June 30, 2032, and any other sources permitted by law, including transfers from existing reserves.
