M. WHEREAS, the Malverne Union Free School District and Guardian Bus Company Inc. are parties to a Transportation Agreement covering the period of July 1, 2019 through June 30, 2020; and

WHEREAS, on March 11, 2020, the World Health Organization declared COVID-19 a global pandemic and, in an effort to protect the health and welfare of its students and their families, the Governor of the State of New York issued Executive Orders requiring that schools be closed beginning on March 18, 2020 through June 30, 2020 ("Closure"); and

WHEREAS, the current Closure may, in accordance with further executive order, be extended past June 30, 2020 and/or may be re-imposed after schools reopen, on account of Covid-19 or similar pandemic; and

WHEREAS, Guardian Bus Company Inc. has agreed to: continue providing contracted services, other than home to school or other student transportation during the current or new Closure; resume student transportation services immediately upon the reopening of schools; accept a rate discounted to 75% of that normally due during the current Closure for the month of April (during which it continued to pay drivers and matrons) and 40% for the balance of the current closure or in the event schools continue to be or are again closed on account of COVID-19 or similar pandemic; guarantee State Aid on said payments; extend the existing contract for the 2020-2021 school year with an increase equal to the cost of living as provided by the NYS Education Department (1.4%) and waive any claim against and promise not to sue the District on account of any claim of breach of contract or non-payment; and

WHEREAS, the District and Guardian Bus Company Inc. have agreed to enter into a Transportation Agreement Amendment incorporating the foregoing provisions; NOW THEREFORE, BE IT RESOLVED, that the Board of Education approves the Transportation Agreement Amendment between the District and Guardian Bus Company Inc.; and be it further

RESOLVED, that the Board hereby authorizes the Board President to execute the Transportation Agreement Amendment on behalf of the Board.

N. BE IT HEREBY RESOLVED that the Board of Education of the Malverne Union Free School District approves the contract with St. James Tutoring for related services for the 2020-2021 school year.

RESOLVED, that the President of the Board of Education be and is hereby authorized to execute both the Disclosure and Consent Agreement and the Intermunicipal Cooperation Agreement on behalf of the District.
