MALVERNE UNION FREE SCHOOL DISTRICT PROVIDER AGENCY SERVICES CONTRACT

This AGREEMENT is entered into this July 1, 2022 by the Board of Education of the Malverne Union Free School District (hereinaster the "DISTRICT"), and FriendZone Kids (hereinaster "PROVIDER"), having its principal place of business for the purpose of this AGREEMENT at Malverne Union Free School District, 301 Wicks Lane, Malverne, NY 11565 and FriendZone Kids as the party of the second part, having his principal place of business for purpose of ths agreement at 60 Maple Road Rockville Centre, NY 11570:

TERM:

This AGREEMENT shall commence on July 1, 2022 and continue thereafter in full force
and effect through the period ending June 30, 2023 inclusive, unless terminated as
hereinafter specified in this AGREEMENT. It is understood that the DISTRICT is under
no obligation to renew this AGREEMENT upon its expiration on June 30, 2023.

CONDITIONS:

In performing services specified in this AGREEMENT, it is understood that:

- PROVIDER will be engaged as an independent Contractor, and therefore be solely responsible for the payment of federal and state income taxes applicable to this AGREEMENT.
- Neither PROVIDER nor any of its employees, agents, or assigns will be eligible for any
 employee benefits whatsoever relative to this AGREEMENT including, but not limited
 to, social security, New York State Worker's Compensation, unemployment insurance,
 New York State Employee's Retirement System, health or dental insurance, or
 malpractice insurance.
- DISTRICT, if required by Federal or State requirements, will submit a Form 1099 and IT
 2102.1 respectively at year-end to the Federal Government for all individuals having a
 gross income exceeding \$600, which thereupon will be reported for income tax purposes.
- This AGREEMENT, and any amendments to this AGREEMENT, will not be in effect until agreed to in writing and signed by authorized representatives of both parties.
- 5. The PROVIDER further agrees that it shall defend, indemnify and hold harmless the DISTRICT, its administrators, board of education, directors, agents and employees for all loss, costs, damages and expenses, including attorneys' fees, judgments, fines and amounts paid in settlement in connection with any threatened, pending or completed action, suit or proceeding, arising from any act, error, omission, misstatement, misleading statement, neglect or breach of duties by the PROVIDER or any of its officers, directors, agents or employees taken or made in the performance of their obligations under then or reasonably assumed with respect to this AGREEMENT.

The DISTRICT further agrees that it shall defend, indemnify and hold harmless the PROVIDER, its administrators, directors, agents and employees for all loss, costs, damages and expenses, including attorneys' fees, judgments, fines and amounts paid in settlement in connection with any threatened, pending or completed action, suit or proceeding, arising from any act, error, omission, misstatement, misleading statement, neglect or breach of duties by the DISTRICT or any of its officers, directors, agents or employees taken or made in the performance of their obligations undertaken or reasonably assumed with respect to this AGREEMENT.

All providers providing services pursuant to this AGREEMENT shall be subject to the
approval of the DISTRICT, which approval shall not be unreasonably withheld. The
DISTRICT specifically reserves the right to reject and/or request replacement of any of
such providers.

SERVICES AND RESPONSIBILITIES:

1. Scope of Services (2022-2023): Shall provide the District with the following services:

Group Counseling Services - \$360 per 6 week sessions

REPRESENTATIONS:

- PROVIDER represents that all services under this AGREEMENT will be provided by
 individuals who are of good character, who are in good professional standing, and
 who possess current and valid licenses / certifications, if any, necessary to perform
 the services under this AGREEMENT. PROVIDER represents that no individuals
 providing services under this AGREEMENT are currently charged, nor in the past
 have been charged with any criminal or professional misconduct or incompetence.
- PROVIDER represents that it is a corporation in good standing with the New York
 Department of State and/or New York State Education Department, if applicable and
 will provide the DISTRICT with proof of same on or before its execution of this
 AGREEMENT.

COMPENSATION:

 The DISTRICT shall pay PROVIDER in accordance with the following fee schedule, following the presentation of detailed invoices by PROVIDER to the DISTRICT:

Group Counseling Services - \$360 per 6 week sessions

- b. As a precondition of payment, PROVIDER shall submit invoices to the DISTRICT on a monthly basis as set forth below.
- For services provided during extra-curricular activities, PROVIDER shall submit
 a separate invoice for the relevant time period.

DEFAULT AND TERMINATION:

- Either PROVIDER or the DISTRICT may terminate this AGREEMENT upon thirty (30) days' prior written notice to the other party. Such notice shall be given in accordance with the requirements for all notices pursuant to this AGREEMENT set forth below.
- In the event the PROVIDER or the DISTRICT terminates this AGREEMENT upon thirty
 (30) days written notice, with or without cause, PROVIDER shall not be liable to the
 DISTRICT for further services, and the DISTRICT shall only be liable to PROVIDER
 for those amounts invoiced for services performed by PROVIDER prior to the effective
 termination of this AGREEMENT.
- The parties agree that PROVIDER'S failure to comply with any terms or conditions of
 this AGREEMENT will be deemed a material breach of contract, and will provide a basis
 for the DISTRICT to immediately terminate this AGREEMENT without any further
 liability to PROVIDER.

NOTICES

 All notices which are required or permitted under this AGREEMENT shall be in writing, and shall be deemed to have been given if delivered personally or sent by registered or certified mail, addressed as follows:

 It is expressly understood that neither party may assign or otherwise transfer its rights, privileges or obligations under this AGREEMENT without prior written consent of the other party.

WAIVER OF RIGHTS

1. The failure of either party to enforce any provision of this AGREEMENT shall not be construed as a waiver or limitation of that party's right to subsequently enforce every provision of this AGREEMENT.

This AGREEMENT and the rights and obligations of the parties hereunder shall be construed in accordance with, and governed by, the laws and regulations of the State of New York and applicable Federal laws and regulations. In any proceeding concerning the enforceability of this AGREEMENT, the parties consent to personal jurisdiction in the Courts of the State of New York.

ENTIRE AGREEMENT:

1. This AGREEMENT may not be changed orally, but only by an AGREEMENT, in writing, signed by authorized representatives of both parties.
