

CONTRACT FOR HEALTH AND WELFARE SERVICES

THIS AGEEMENT made in triplicate this twenty seventh day of May 2022, by and between the Malverne Union Free School District as trustee of the union free school district, town of Malverne of New York party of the first part, and Great Neck Union Free School District as trustee of union free school district, town of Great Neck, county of Nassau, New York, part of the second part.

WITNESSETH, That whereas party of the first part has been duly empowered by the provisions of section 912 of the Education Law to enter into a contract for the purpose of providing health and welfare services for children residing in said school district and attending nonpublic schools in union free school district of Nassau, New York to begin on September 1, 2021 and to end June 30, 2022.

Now, Therefore, the said party of the first part hereby agrees to pay to the party of the second part the sum of \$2,033.70 for health and welfare services to be provided under section 912 to approximately two children residing in said union free school district, town of Malverne attending non public schools in said union free school district town of Great Neck, county of Nassau, New York.

And the party of the second part hereby agrees with the party of the first part as follows:

1. *That the health and welfare services provided under section 912 shall consist of the following:

Physician Services
Dentist Services
Dental Hygienist Services
Nurse Services
School Psychological Services
School Social Work Services
School Speech Correctionist Services

...Such services may include, but are not limited to all services performed by a physician, dentist, dental hygienist, nurse, school psychologist, school social worker or school speech correctionist, and may also include dental prophylaxis vision and hearing tests, the taking of medical histories and the administration of health screening tests, the maintenance of cumulative health records and the administration of emergency care programs for ill or injured pupils....

2. The party of the second part will also furnish the following equipment to be used in providing such services if requested by the authorities in charge of the nonpublic school:

Supplies and equipment for use by physician, school nurse-teacher, psychologist, Dental Hygienist, Social Worker, and Speech Correctionist (i.e., Scales, Vision and hearing testing devices, Health record forms, First-aid supplies, and all other readily transportable equipment and supplies pertaining to delivery of services).

It is expressly agreed by and between the parties hereto that the services agreed to be supplied under this contract shall not include any teaching service.

It is mutually agreed that this contract shall not become valid and binding upon either party thereto until the same shall be approved by the MalverneUnion Free School District superintendent of schools.
