WHEREAS, the Malverne Union Free School District, as the only involved agency, has examined all information related to the capital improvement project and has determined that said capital improvement, including procurement of Multi-Sport Stadium Seating, Media Tower, Score Tables, Grandstands, and Acoustic Sound Shells at Malverne High School, is classified as a Type II Action pursuant to Section 617.5 (1), (2), (10) of the SEQRA Regulations;

NOW, THEREFORE, BE IT RESOLVED that the Malverne Union Free School District hereby declares itself lead agency in connection with the requirements of the State Environmental Quality Review Act; and

BE IT FURTHER RESOLVED that the Malverne Union Free School District hereby declares that the capital improvement project including procurement of Multi-Sport Stadium Seating, Media Tower, Score Tables, Grandstands, and Acoustic Sound Shells at Malverne High School is a Type II Action, which requires no further review under SEQRA; and

BE IT FURTHER RESOLVED that the Malverne Union School District hereby shall forward an official copy of this Resolution to the New York State Education Department together with a copy of the correspondence from the New York State Office of Parks, Recreation and Historic Preservation in connection with its request for approval of the listed projects from the New York State Education Department.

B. RESOLVED, that the proposed Intermunicipal Cooperation Agreement ("IMA") with Nassau County whereby the County will provide financial assistance to enable the District to purchase, procure and install multisport stadium seating (bleacher seats), media towers, scorer's tables, grandstands and related items at Malverne High School and acoustic sound shells for the Malverne High School Performing Arts Center be and the same is hereby approved, and be it further

RESOLVED, that the President of the Board of Education be and is hereby authorized to execute the said IMA and any other documents required in connection with the said IMA on behalf of the District.
